"VOTED: To appoint Michael Robert Murphy of Boston, MA



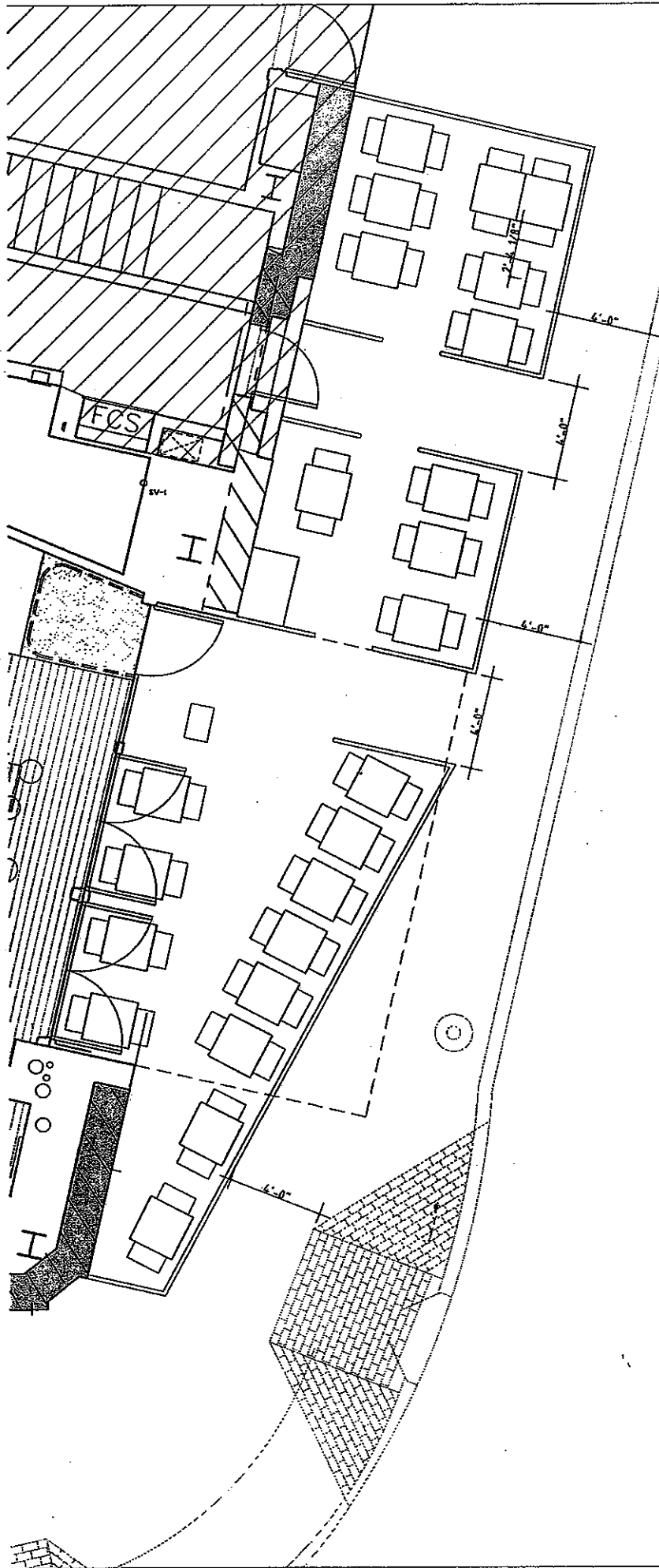
